- 3. Community forums in each region Staff gave an update on all the meeting days/times in each region. Regions have been reaching out to their providers and other groups in their regions with flyers about the forums.
- 4. Review RA process from last year There are 2 service categories where the resource allocation process needs to be reviewed, specifically, housing and substance abuse inpatient care. The recipient will bring back data on these in April that will include breaking down expenditures from GY2023 by rent, bed days and FTE.

• Review Intensive Medical Case Management Monitoring Results

Staff presented the outcome from the IMCM monitoring results from all 5 regions. The IMCM uses funding from minority AIDS initiative only and must meet those requirements for eligibility. The results showed that some clients were enrolled in this but did not meet the eligibility requirements and this will be addressed in the full report that will be done.

• Review the GY2023 Directives and Update for GY2024

Joanne read through the current directives and all directives were good except directive 8.0. There was discussion about this one and we will continue to review this in February.

• Review and Update By Laws and the Policy & Procedure Manual

Staff presented this and discussed all updates that may need to be made. It was decided that this will be emailed out to all PC members for review prior to February's meeting where we'll discuss this again.

• Review Scope of Work for GY2024

Staff presented the current Planning Council activity timeline. We will be adding a new item, 'Quarterly review of the EMA's CQM performance measure portfolio from the Recipient's Office'.
