New Business/Old Business (4.0)

Review the Quality Improvement/Strategic Planning and Assessment Planning Council Activity Timeline

The Committee reviewed the Planning Council Activity Timeline and determined that everything was on track.

Review Framework for Priority Setting and Resource Allocation Process

The committee discussed the following items:

- 1. What datasets need to be brought current and do we want to add any new assessments to the priority setting process. The following datasets will be looked into further; Behavioral Heath, Community Forums with Gilead in each of the five regions, regional utilization/expenditures and service units and a collaboration with the state DPH for a comprehensive needs assessment of all clients. Staff will reach out to Gilead and ask them to join us next month via Zoom regarding the community forums and topics to be discussed.
- 2. We will look at the drop-down lists in CAREWare and review all the service details that can be entered for that service and review consistency across all regions.
- 3. Another item discussed was the datasets and weighting process, we'll continue to investigate this.
- 4. A concern regarding the Intensive Medical Case Management component of MCM was brought up and staff will investigate usage of this service.
- 5. There will be a small workgroup meeting to discuss an evaluation of the regional system and staff will send out a Doodle poll to set up a meeting via Zoom.

(5.0) **Review and Update Service Category Definitions and Service Standards**

This was discussed and it was determined that we'll review the service category drop down lists from Arvil next month to inform us as to what updates should be made.

(6.0) **Discuss Structure of this Committee**
